Executive Summary

Criminal Background

- **Candidates with Criminal Cases:** Out of the 432 candidates analysed, **55 candidates (13%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **30 candidates** have declared serious criminal cases relating to attempt to murder, crimes against women, criminal intimidation etc.
- **Party wise Candidates with Criminal Cases:** **6 (21%)** out of **28** candidates fielded by **INC**, **9 (32%)** out of **28** candidates from **BJP**, **8 (32%)** out of **25** candidates from **JD(S)** and **14 (7%)** out of 194 **Independent** candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **4 (14%)** out of **28** candidates fielded by **INC**, **4 (14%)** out of **28** candidates from **BJP**, **3 (12%)** out of **25** candidates from **JD(S)** and **9 (5%)** out of 194 **Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Attempt to Murder:** **2 candidates**, **Pramod Mutalik** an **Independent** candidate from Bangalore South constituency and **B Sreeramulu** of **BJP** from Bellary constituency have declared **cases related to attempt to murder**.
- **Candidates with Crimes against Women:** **2 candidates** have declared cases related to crimes against women. **Rajagiri T.D** of **BSP** from Chitradurga constituency has declared a cases related to **assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)** and **Dr. Banuprakash.K**, an **Independent** candidate from Hassan constituency with a case of **husband or relative of husband of a woman subjecting her to cruelty (IPC Section-498A)**.
- **Red Alert Constituencies*:** 8 out of 28 constituencies in Karnataka have at least 3 candidates with declared criminal cases.

**Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.*

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section

Financial Background

- **Crorepati Candidates:** Out of the 432 candidates, **118 (27%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **27 (96%)** candidates out of 28 from **INC**, **26 (93%)** candidates out of 28 from **BJP**, **21 (84%)** out of 25 candidates from **JD(S)** and **12 (43%)** out of 28 candidates from **AAP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting from Karnataka in Lok Sabha 2014 elections is **Rs. 22.98 crores**.

- **Party-wise Average Assets:** Among major parties, the average assets of **28 INC** candidates is **Rs 293.75crores**, **25 JD(S)** candidates have average assets of **Rs. 30.40 crores**, **28 BJP** candidates have average assets of **Rs 14.65 crores** and **28 AAP** candidates have **Rs 8.49 crores**.
- **High Asset Candidates:**15 candidates have declared more than **Rs.50 crores worth of assets**. Total assets include assets of Self, spouse and dependents. The top three candidates with highest assets are given below:

- **Candidates with Liabilities:** A total of **215** candidates out of 432 have declared liabilities **out of which 35** candidates have declared liabilities **above Rs 1 crore.R. Prabhakara Reddy** of **JD(S)** from Bangalore Rural constituency has declared liabilities of **Rs. 221.80 crores** followed by **H D Kumara Swamy** of **JD(S)** from Chikballapur constituency with liabilities of **Rs 72.96 crores** and **Suresh Angadi** of **BJP** from Belgaum constituency declaring total liabilities of **Rs 36.62 crores**
- **Candidates with High Income*:**A total of 177 candidates have declared their income tax details **out of which 22** candidates have declared a total income of more than **Rs 50 lakhs**. **Nandan Nilekani** of **INC** from Bangalore South constituency has declared the highest total income of **Rs 168.41 crores** followed by **Manju. A.** of **INC** from Hassan constituency with a total income of **Rs 14.04crores** and **R. Prabhakara Reddy** of

- **Candidates who have not declared Income Tax Details*: 255(59%)** candidates out of 432 analyzed have not declared income tax details. * Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details: 10** candidates with declared total assets worth more than Rs 1 crore have not declared Income Tax Details. The top three candidates with high assets who have not declared income tax details are as following:

- **Undeclared PAN: 133 (31%)** out of 432 candidates analyzed have not declared their PAN details.
- **Crorepati Candidates who have not declared PAN details: 4** candidates with total assets worth more than **Rs. 1 crore** have not declared their PAN details.

Other Background details (Education, Gender, Age)

- **Candidates Education: 190 (44%)** out of 432 candidates have educational qualification of **12th pass or below**, while **217 (50%)** candidates are **graduates or possess higher degrees**. **6** candidates have declared that they are **illiterate**.
- **Candidates' Age: 261 (60%)** out of 432 candidates have declared their age to be between **25 to 50 years** of age. **150 (35%)** candidates have declared their age to be between **51 to 70 years** of age. **17** candidates are in the age group of **71-80 years** while **1** candidate has declared his age to be **more than 80 years**.
- **Women Candidates: 20 (5%)** out of 432 candidates are women.

Detailed Analysis based on declared criminal cases

Out of the 432 candidates analysed, 55 candidates (13%) have declared criminal cases against themselves. 30 candidates (7%) have declared serious criminal cases relating to attempt to murder, crimes against women, criminal intimidation etc

Party-wise candidates with declared criminal cases

6(21%) out of 28 candidates fielded by **INC**, **9 (32%)** out of 28 candidates from **BJP**, **8 (32%)** out of 25 candidates from **JD(S)** and **14 (7%)** out of 194 **Independent** candidates have declared criminal cases against themselves in their affidavits.

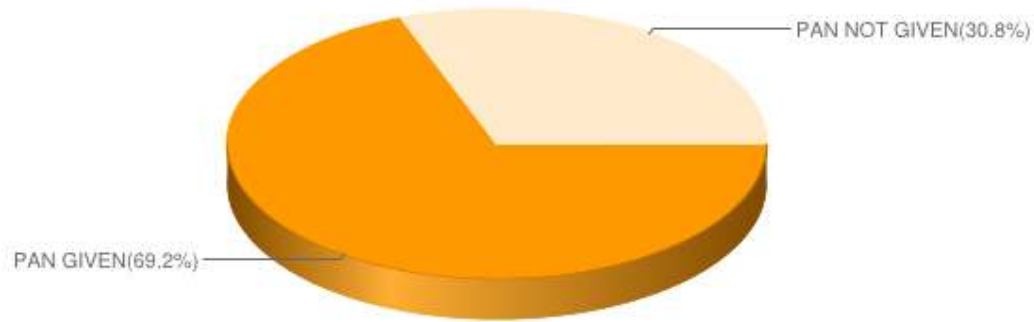

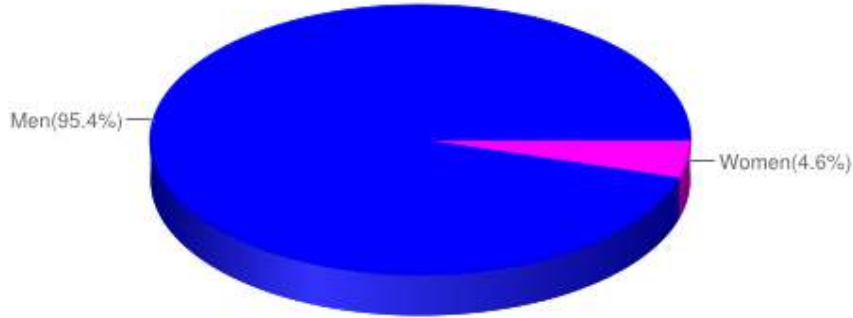
